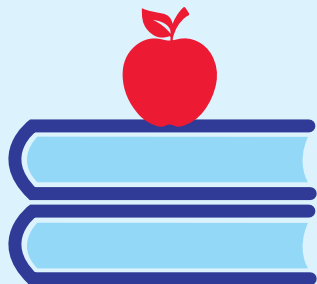

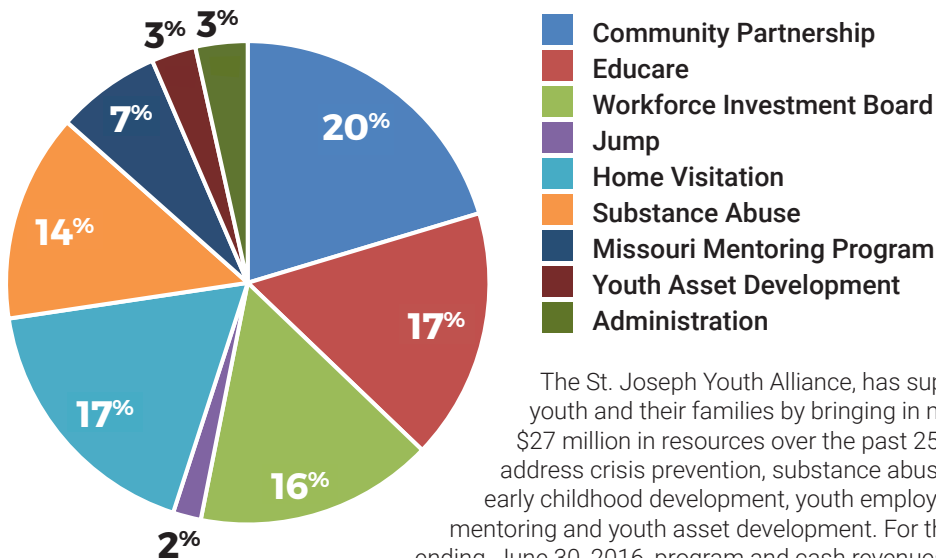

Fiscal Year 2015-2016 Revenues



The St. Joseph Youth Alliance, has supported youth and their families by bringing in more than \$27 million in resources over the past 25 years to address crisis prevention, substance abuse prevention, early childhood development, youth employment/mentoring and youth asset development. For the fiscal year ending, June 30, 2016, program and cash revenues totaled \$1,363,793.68. Volunteers logged 1533 hours valued at \$31,043.25. In-kind donations totaled \$413,490.95. Overall, the Youth Alliance's total contributed resources for FY 15-16 were valued at \$1,808,327.88.
